1) PUBLIC COMMENT

Members of the public will be given the opportunity to directly address the Committee on any item listed on the agenda.

Public Comment was provided at various points during the meeting.

2) North Santa Monica Boulevard Bicycle Lane Treatments

Deputy Director of Transportation Aaron Kunz provided an update on the North Santa Monica Boulevard Bicycle Lane Treatments, scheduled for installation at the completion of construction of the Boulevard. While the bicycle lanes have been approved for installation, the design, color, and other features still require authorization from City Council. Iteris Consultant Michael Meyer presented further background information regarding regulations for color, material, and design features to increase visibility.

Vice Mayor Gold requested to hear from City staff and members of the public in attendance. Topics and questions voiced by the group included the following:

- State regulations for bicycle lane colors
- Regional and nationwide bicycle lane fill designs and safety features
- Bicycle lane fill at approach of and through intersections
- Vehicle and lane widths
- Durability levels and costs of different types of paint

Vice Mayor Gold asked for further examination of turn volumes along North Santa Monica Boulevard. The Committee directed staff to bring the item forward to City Council.

3) Complete Streets Plan Program Process

Transportation Planner Martha Eros and Iteris Consultant Sam Morrissey presented an update on the amended role and composition of the Project Advisory Group. The Traffic and Parking Commission will act as the advisory group for the project.

Topics and questions voiced by the group included the following:

- Collection of public comment at Commission meetings and community meetings
- Inclusion of accommodations for transportation network company vehicles (Uber, Lyft, etc.), autonomous vehicles, and commercial delivery vehicles in planning process
- Necessity of regular communication with the Police Department and Information Technology for the project

Vice Mayor Gold mentioned that two or three public community meetings may not be enough. The Committee directed staff to continue moving forward in the planning process for the Complete Streets Project.
